GENERAL INFORMATION

Entry fees. TD - \$75.00; TDX - \$125.00. Includes \$0.50 AKC Recording Fee and \$1.50 AKC event service fee.

Mail all entries with fees to Donna Thompson, 1144 Reynolds Rd., Cross Junction, VA 22625. Make checks payable to ABMC. There will be a \$25 collection fee added for any returned check.

DRAWING OF ENTRIES: Entries shall be accepted until the official closing date, even though the advertised limit has been reached. Entries will be drawn by the Test Secretary on Wednesday, April 27, 2016, at 6 p.m. at the home of the secretary. The Drawing shall be completely random among all entries received, except that preference shall be given to dogs in the following order: Draw (1) Specialty breed without a title; Draw (2) Specialty breed with a title; Draw (3) Other breeds without a title; Draw (4) Other breeds with a title. When the advertised limit has been drawn, remaining entries, subject to the same preferences set forth above, shall be assigned a position on an Alternate List corresponding to the order in which they were drawn. The Test Secretary shall then notify all entries of the results of the draw.

Extreme Weather. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and or the ingress and egress from the grounds must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the event before completion, no refund of entry fee will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline (877) 252-3229.

Certification. With each TD test entry of a dog that has not passed an AKC tracking test, there must be filed an original statement, dated within one year, signed by a person who has been approved by the AKC to judge a tracking test, certifying that the dog is considered to be ready for such a test.

Bitches in season may participate. They will be assigned the last track(s). Please report to the Test Secretary before the drawing for track order on the morning of the test.

Refund policy. No entry shall be refunded except as follows. Entry fees and certification will be returned within 7 days following the test for an alternate who does not participate in the test. Entry fees shall be returned for a dog withdrawn because it has passed a tracking test between close of entries and Saturday, May 7, 2016, if such dog is replaced by an alternate. Withdrawal requests must be made to the Test Secretary by Saturday, May 7, 2016.

Drawing for the running order of TD tracks will take place at Test Headquarters on the date of the test at 7:30 a.m. Drawing for the running order of TDX tracks will take place at 9:30 a.m.

Awards: All qualifiers will receive a green rosette, a new title rosette, and a Sack Pack with the 2016 logo. TDX qualifiers will receive a Sack Pack with the 2016 logo and an ABMC medallion.

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
