Parking

RV's may not be parked overnight or in the lot in the front of the building. They may be parked on the side of the building. During trial hours.

Crating

Please pay attention to the signs. No crating in walkways/hallways around the outside of the turf. **Turf crating is limited to ABMC members, handicapped, and preapproved helpers only.**

Dogs must be exercised on lead in the designated areas only. There is absolutely no exercising of dogs in the back of the Sportsplex. Failure to comply and failure to clean up after your dog at the Sportsplex or Motel will result in the exhibitor being excused from the trial without a refund.

Move-ups are due by 6 p.m., May 9, 2016 in writing (email is preferred). Day to day move-ups are allowed and must be submitted in writing at the trial within 10 minutes after the last class on Saturday.
