Minutes ABMC BOD Meeting September 17, 2024

1. Meeting was called to order by President Paige Johnson at 7:43 pm CST.

- 2. Approved minutes of August 13, 2024 BOD Meeting. Jeanine moved to accept the Minutes as printed; Suzanne seconded; approved.
- 3. Treasurer's report: Discussed. Detailed account located elsewhere in The Performer.
- 4. Committee Reports:
 - 4.1 2025: Everything is on schedule; most of the trophies have been chosen; deposits are paid for all trophies. Sara is working on securing vendors.
 - 4.2 2026: Scheduling of the Roberts Center is still up in the air; Dina is checking on other venues; we need to finalize contracts with judges.
 - 4.3 Others Committee Reports:
 - 4.3.a Linda Freidow Judges Ed: The AKC Canine College Course for the Belgian Malinois was completed a few months ago. Judges and breeders should have received a notice from AKC that it was available for purchase/viewing. A HUGE thank you to all that helped with content, interviews, photos, videos, etc. Mentoring help was offered at Amana Regional thanks again to those that offered their dogs for hands on and conversation with them judge learning the breed.
 - 4.3.b Carolyn Kaiser Register of Merit: No new ROM applicants.
 - 4.3.c Monique Buzzarte Herding Committee Report: FYI #1 The shift to a quarterly rather than bi-monthly Performer coupled with the shift to quarterly rather than monthly "AKC Herding Report for Belgian Malinois" results in a very tight turn-around time to prepare the rankings. For example, in July the report from the AKC arrived July 26th and the Performer "deadline" was July 19; the previous issue was similar. Kudos to Sara for being so understanding, and STILL getting the information into the Performer. FYI #2 The Performer issue that is slated to features herding is the Jan-Feb-March issue, with a deadline in February. I've proposed to Sara that she seek permission to

- 6.1 Publishing BOD ZOOM information: information regarding access to the BOD ZOOM meetings will be posted in the Belgian Beast. Any member may attend, but will be muted. There may be times when an executive session is necessary.
- 6.2 Although they did not want to file a formal complaint regarding certain breeding practices, two members proposed creating an Ethics Committee. The BOD will have those members present a formal proposal including a mission statement, the purpose(s) of the committee, standards over which the committee will have jurisdiction, means of policing said standards, procedures, consequences, etc. Once that information is received, the BOD will determine the efficacy of presenting such a proposal to the Membership for approval.
- 6.4 Canine Health Fund: Discussion regarding where to donate ABMC's portion of the AKC Canine Health Fund in order to best serve our breed. The suggestion was made to reach out to the veterinarians who are members for their input. Currently, our fund is approximately \$4,400.
