A NOTE FROM THE BOARD:

The January ABMC Board meeting was recently held and several important issues were discussed. Co-Chairs for the 2025 National Specialty updated the Board that planning is ahead of schedule, and Regional Specialty trophies and all rosettes have been received. Co-Chairs were pleased to announce that a couple of educational opportunities will be held at this years specialty. A Canine CPR & First Aid class will be offered on May 7, 2025 in the Founders Room and a portion of the proceeds will be donated to ABMR. Also, the Upright Canine Brigade will be on site to offer education about Megaesophagus and Myasthenia Gravis. A quick update was provided by the 2026 Show Chair that planning is going great and she is working to secure her Obedience & Rally Judges and a host hotel.

Allison Bath has graciously agreed to remain as chair of the ABMC Conformation Committee. She will be monitoring AKC for important updates to the Conformation events and will be relaying those to the ABMC Board and the general membership. If you wish to volunteer for this committee please feel free to reach out to her.

The Board is pleased to announce that the Meet the Breeds policies, procedures and application have been updated. Dogs that will be working at a Meet the Breeds event no longer have to have a CGC Certification and only the chair of an event must be an ABMC member. The Board made these changes in an attempt to grow our Meet the Breeds program the Board feels it is very important to educate the public on out wonderful breed.

There was a short discussion on ABMC sponsored awards. The medallions for the AKC National Championship (all venues) were in fact sponsored by the ABMC, however there was a miscommunication and the medallions were not handed out by AKC at the National Championship. ABMC Treasurer Suzanne Belger contacted AKC as soon as the Board was informed there was an issue with them. Suzanne was originally told by AKC in December that the medallions would be mailed out the end of January. Suzanne followed up with the AKC and is now being told by AKC that they will NOT be mailing out any medallions after the fact. Sadly, due to the miscommunication with AKC no medallions will be sent out this year. In an attempt to provide some consolation, the Board will be sending an ABMC an engraved Medallion to each person who qualified for one at the National Championship. Please accept the Board sincerest apologies for this issue. The Hall of Fame plaques that were given out at the 2024 National Specialty were unfortunately missing the words "Hall of Fame". Theresa Kulb has reordered those and will be sending corrected plaques to everyone who received an incorrect one. The incorrect plaques are available for anyone who would like to used them as a trophy for any ABMC sponsored event.

In an attempt to remain transparent and abide by the current ABMC Bylaws, the ABMC will be hiring UHY LLP (formerly Baird, Cotter & Bishop PC) to perform an independent audit of the ABMC financials. The independent audit will be done for the previous two years (2023 & 2024) and will cost approx. \$4,000. However this must be done in order to remain in compliance with the ABMC Bylaws.

The Board received and reviewed one ABMC Event Application from Judy Hagen for a Regional Specialty & supported entry to be held August 30 & 31, 2025 at the Tri-Cities Kennel Club & Cedar Rapids Kennel Ass. in Amana, IA. The Board unanimously approved this event and would like to thank Judy for her time and dedication to the ABMC.
