The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Belgian Malinois Club Inc and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Belgian MalinoisClub Inc reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Belgian Malinois Club Inc or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

Crating space will be available on a limited basis. The event site requires a tarp or other cover to be placed on the floor underneath your crates and chairs. Crates maybe left overnight; however, the American Belgian Malinois Club Inc and Ann Arbor Training Club will not be responsible for any lost or damaged items left at the show site.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Dogs may arrive any time prior to judging if the dog has a valid temporary orpermanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ENTRY METHOD: FIRST RECEIVED

ENTRIES WILL OPEN ON [Wednesday, April 7, 2021, 6:00 AM EDT] at the Trial Secretary's address. All entries received before this date will be returned. Overnight or certified mail must be sent with the "No Signature Required" waiver signed.

ENTRIES CLOSE ON [Wednesday, May 19, 2021, 6:00 PM EDT] after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry.

JUMP HEIGHT CARD PROCESS

entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the Dogs To Be Measured List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the Judge of Record PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, orany other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. If the trial is cancelled because of COVID-19, the ABMC will offer a full refund to exhibitors.

Bitches in season are not eligible participate in Agility Trials. Please note: there will be a refund of entry fees for bitches entered in the trial that come in season after the closing date (May 19, 2021) and for dogs injured after closing. This may be obtained by sending a veterinarian's certificate to the trial secretary at least one-half hour before the start of the show. Entry fees will be refunded less \$5.00 per run AKC and judge's fee.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medicalpurposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

WAIT LIST INFORMATION

American Belgian Malinois Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. All entries, including wait listed entries, must be received by the Trial Secretary prior to Wednesday, May 19, 2021 6:00 PM EDT. Any entry withdrawals that are received by Sunday May 16, 2021, NOON EDT will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listedentry that does not move off the wait list into the trial by May 19, 2021 will receive a full refund.

COURSE WALK-THROUGHS AND WARM-UPS

Handlers in all classes are permitted to walk the course, without a dog, during a walk- through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiplerings may request to walk with a height group other than the one their dog is entered inif a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes <u>must</u> compete at the required jump height and **may not** compete in a jump height division **higher or lower**

then their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners Program M may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes <u>must</u> compete at the required jump height and **may not** compete in a jump height division **higher or lower**

then their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners Program SM may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. I understand the risk of becoming exposed to or infected by COVID-19 at these agility trials held at Ann Arbor Training Club, June 3, 2021, may result from the actions, omissions, or negligence of myself and others, including, but not limited to, The American Belgian Malinois Club, Inc. show staff, employees, volunteers, participants, attendees, and their families. I hereby release, covenant not to sue, discharge, and hold the American Belgian Malinois Ann Arbor Training Club, its agents, directors employees volunteers attendees or other participants from any claim.

Social Distancing:

- I will, to the best of my ability, practice proper social distancing as recommended by the State of Michigan, as well as practicing good hygiene (hand washing, use of hand sanitizer, wearing a mask at all times when in the building except when running my dogs (mask may be taken off in the ring and placed in your pocket, then put back on before exiting the ring) and when around other people on the grounds) and follow any other health recommendations. +
