Test Locations: Both tests take place in and around Mason, MI 48859

Number of Tracks: The combined TD/TDX test is limited to 4 tracks each, with the numbers of TD and TDX tracks adjusted based on entries received, in accordance with Ch. 1, Sec. 17a and 19.

Entries close: at 6:00 pm, Wednesday, May 19, 2021. Drawing for entries and alternates will occur at 7:00 pm at Bay Beach Park main parking lot, 1313 Bay Beach Rd., Green Bay, WI 54302. All interested persons may attend. Exhibitors will receive an email with the results of the draw within 48 hours, or may call 920-606-5641 after 8:00 pm, Wednesday, May 19, 2021, for the results. The drawing of entries will be executed in accordance with Ch. 1, Sec. 17, 17a & 17b of the AKC Tracking Regulations.

Test Headquarters (HQ): Laylin Park, 540 E. Maple, Mason, MI 48859. Upon arriving at park, follow signs to test headquarters (HQ).

Test hours: are 6:00 am to 7:00 pm June 1, 2021. Michigan is in the Eastern Time Zone.

On Tuesday, June 1, 2021, all dogs entered in the **TD test** are to be available at Test HQ at 7:15 a.m.. The draw for running order will take place at 7:30 am. TD judging will begin as soon after the draw as the first track is ready.

All dogs entered in the **TDX test** are to be available at Test HQ at 7:15 am. The draw for running order will take place immediately following the draw for the TD test (scheduled at 7:30 am). TDX judging will begin as soon as possible after the TD test is complete and the first TDX track is ready.

ELIGIBILITY: Open to all breeds, with preference given to Belgian Malinois in accordance with Chapter 1, Section 17b of the AKC Tracking Regulations. Draw priority will be as follows: (1) Belgian Malinois not already having the title for the test entered; (2) Belgian Malinois already having the title for the test entered; (3) Other breeds not already having the title for the test entered; (4) Other breeds already having the title for the test entered. Bitches in season may participate in this test in accordance with Ch. 2, Sec. 8 of the AKC Tracking Regulations.

TRACKING CERTIFICATION: Entries in the TD Test must be accompanied by an original written statement, dated within 24 months prior to the TD test, signed by either a person who has been approved by the American Kennel Club to judge Tracking Tests, or by a person/evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, and must certify that the dog is considered by him/her to be ready for such a test.

SEVERE WEATHER: The club may cancel the event in extreme weather conditions.

MANAGEMENT OF DOGS AT TEST: Dogs must be leashed or crated at all times.

YOUR DOG'S HEALTH: Exhibitors should follow their veterinarian's recommendations to assure that their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

THIS TEST WILL ADHERE TO ALL STATE AND LOCAL REGULATIONS RELATED TO THE COVID-19 PANDEMIC. This may include mask-wearing and social distancing.

ENTRY FEES (in U.S. Funds): TD: \$75.00. TDX: \$125.00.

This includes AKC fees. An AKC Event Service Fee of \$3.00 and an AKC Recording Fee of \$0.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. This fee is to be collected by the trial-giving club and paid to the American Kennel Club, per American Kennel Club Rules, Ch. 11, Sec. 2. Entries not on an official entry form and photocopies of entry forms without Agreement and Rules on the reverse side of the official AKC entry form are NOT ACCEPTABLE. Entries will not be accepted without fees and signature. No entries requiring a signature for delivery will be accepted.

Send entries to the Test Secretary, Mary Phillips, PO Box 8022, Green Bay, WI 54308-8022. Entries close on Wednesday, May 19, 2021, at 6:00 PM. Make checks payable to "ABMC." There will be a \$25.00 charge for any returned check.

REFUNDS of entry fees for alternates who don't participate in the test will be sent within one week of the completion of the test. Entry fees for dogs which pass an AKC approved test after the closing date of this test will be refunded if they withdraw from this test provided there is an alternate to replace the entry and the Test Secretary is notified **in writing** not less than 3 days before the test date. Any cancellation of entries must be made in writing and received prior to the closing date.

TROPHIES: Each dog passing a test will receive a green rosette and a leash rack.

The American Belgian Malinois Club (ABMC) offers trophies through the generosity of donors to the trophy fund. All donor names will be listed in the specialty catalog. All ribbons, awards and trophies, if not awarded in the ring, must be picked up by the exhibitor. No trophies will be mailed. Rosettes are offered for all awards and placements by ABMC. Trophies of greater or equal value may be substituted at the discretion of the Test or Trophy Chair.

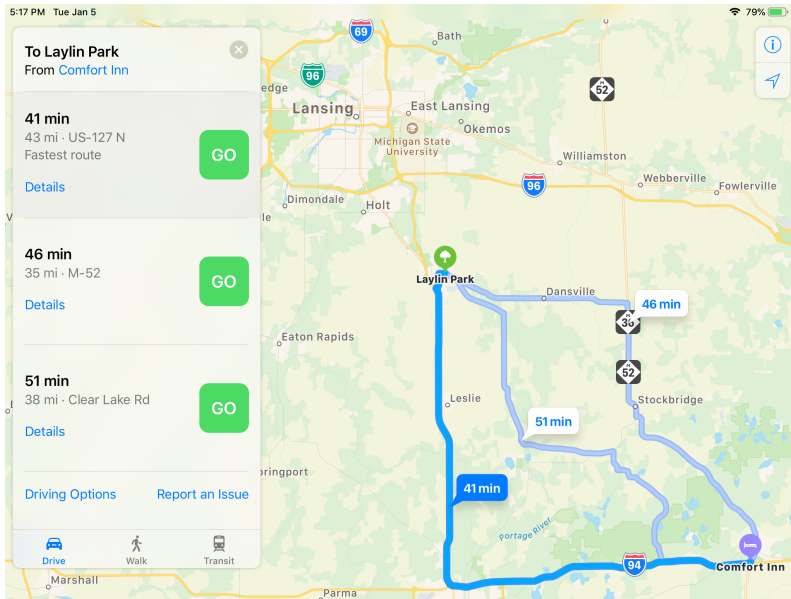

INSTRUCTIONS

(Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in., but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

(Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
