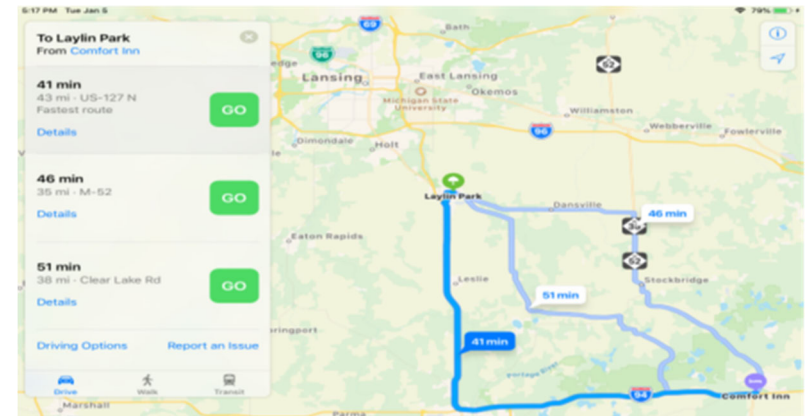

**Test hours:** are 6:00 am to 7:00 pm June 1, 2021. Michigan is in the Eastern Time Zone. On Tuesday, June 1, 2021, all dogs entered in the **TD test** are to be available at Test HQ at 7:15 am. The draw for running order will take place at 7:30 am. TD judging will begin as soon after the draw as the first track is ready.

All dogs entered in the **TDX test** are to be available at Test HQ at 7:15 am. The draw for running order will take place immediately following the draw for the TD test (scheduled at 7:30 am). TDX judging will begin as soon as possible after the TD test is complete and the first TDX track is ready.

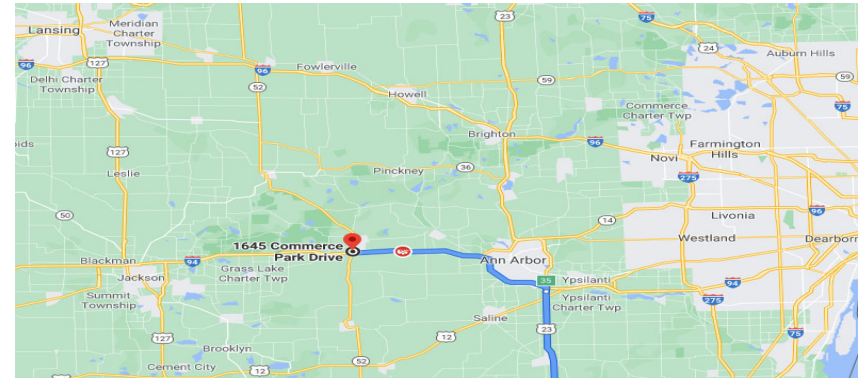

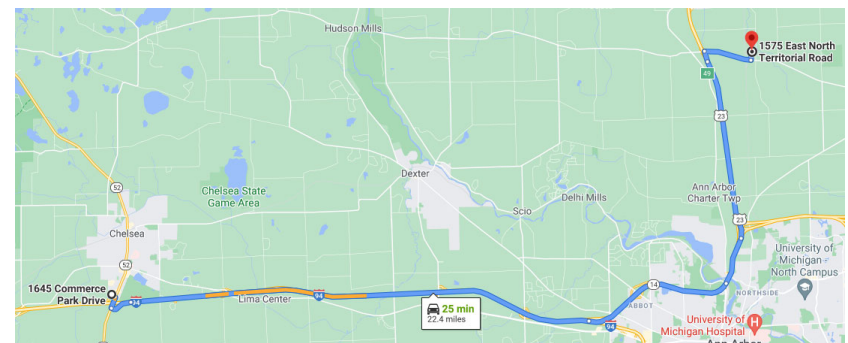


**Directions to Ann Arbor Dog Training Club

**From Lansing:** I-96 east to US -23 South to North Territorial Rd (exit 49). Follow the roundabout to East North Territorial (third exit). Exit Roundabout 1.1 miles to Hoban Way. Turn left 0.2 miles to show site.

**From Toledo or Ann Arbor:** US-23 North South to North Territorial Rd (exit 49). Follow the roundabout to East North Territorial (third exit). Exit Roundabout 1.1 miles to Hoban Way. Turn left 0.2 miles to show site.

**From Detroit:** I-96 east to M-14 east to Gottfredson Rd (exit 15). Turn right to North Territorial. Left on North Territorial approximately 8 miles to Hoban Way (turn right) just past Nollar Rd. before railroad tracks. 0.2 miles on Hoban Way to show site.

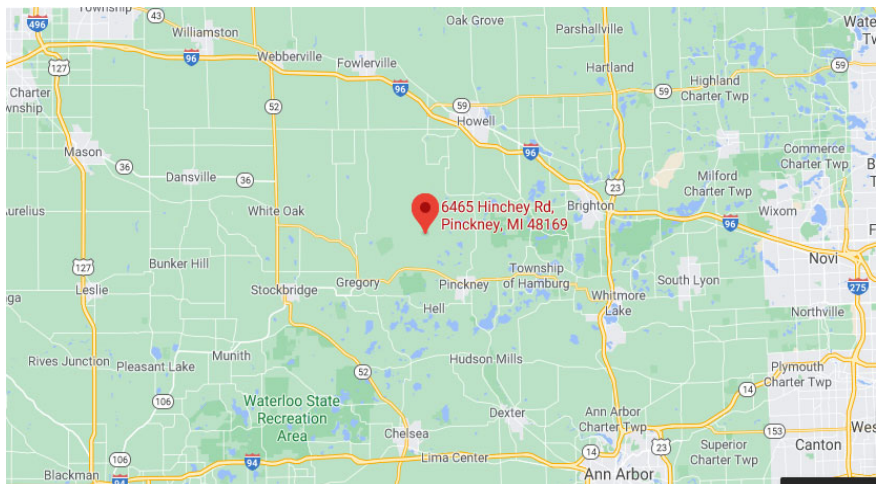
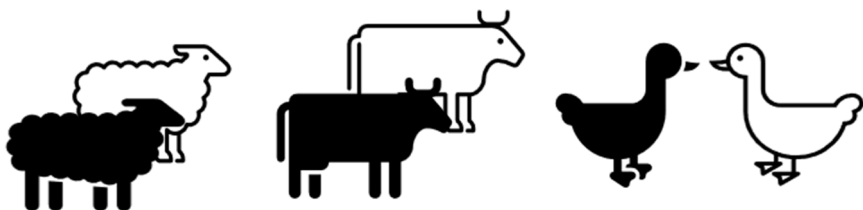

**(Herding Trials and Tests Site)**

**From the Host Hotel** (Chelsea, MI) - Follow Commerce Park Dr To M-52 North (South Main Street). Turn LEFT onto M-52 North (S Main Street) and follow for 16.2 miles. At the Traffic circle, make the first EXIT onto Werkner Road. Continue onto Island Lake Rd. Turn LEFT onto Stofer Rd. Continue onto Hadley Rd 4.2 miles. Slight LEFT onto Kaiser Rd. Continue on Unadilla Rd. After 1.2 miles, turn RIGHT onto Doyle. After less than a mile, turn LEFT onto Livermore Rd. Merge onto M-36E and go for 2.8 mi.. Turn LEFT onto Hinchey Road.

**From I96- North of the farm** (Howell, MI) - Exit I96 at exit #137 and turn south onto Pinckey Rd. After 5.5 miles, turn RIGHT onto W Schafer Rd, then a quick RIGHT onto Cedar Lake Rd, then a LEFT again onto W Schaffer Rd. After .5 miles, turn left onto Hinchey Rd.
