**Belgian Malinois will be given preference in the run order.**

***Move-ups will be offered. Handler must fill out the AKC Class Transfer Form and place it in the marked box as soon as your run is over and your dog is crated. The Move-up box will be available next to the forms at the TS table. Moved dogs will run last.***

### DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

**Condition of the Dog.** Dogs with physical challenges(including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

**Entries not admitted to the trial and withdrawn entries will be shredded; not be returned to the exhibitor.**

## WAIT LIST INFORMATION

ABMC is offering a wait list of 50 runs per trial. Any entries not admitted to the trial will be shredded. Any entries withdrawn will be shredded.

**CLOSING DATE.** No entries may be withdrawn with a refund after closing on April 23, 2022 at 5:00 pm EST. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

## STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

**Staging Area** will be out of view of search area(s). Staging area will include crating, warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

**Warm-up area:** The club shall designate a warm-up area. One labeled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers.

## SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

**Search Area Conditions:** Searches may be indoors, on matted, carpeted, concreted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

**Search Area Sizes** will be as specified in AKC Scent Work regulations.

## ADDITIONAL SITE INFORMATION

**Trial Limit:** Trial will be limited to 250 entries per day, 125 per judge.

**Trial Site:** It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future. This is a private property.

**Potty Area:** Designated potty areas will be pointed out during the Handler Briefing. The restroom facilities for exhibitors are located in the barn.

**Exhibitors are responsible for using appropriate potty area and cleaning up after their dog(s).** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

**Possession of Odors and Training:** Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

**Spectator Area:** Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be asked to leave the area by the judge. Spectators are forbidden to discuss details of the search with handlers who have not run.

**Crating space:** Indoors in air conditioning. Empty crates may be left overnight, however ABMC and property owner will not be responsible for any lost or damaged items left at the show site.

**Parking:** Ample parking is available at no charge to exhibitors, however no RV's are allowed in the regular parking lot. If you plan to bring your RV, please plan to stay overnight in the RV Parking Lot. Golf carts are available to rent onsite. If you are found in violation you will be asked to leave with no refund for missed runs. No overnight parking.

**Smoking and Alcohol:** The grounds are a smoke and alcohol-free area. You may smoke in your own vehicle away from other exhibitors.

**While not actively searching, dogs MUST be on a fixed length 6' or shorter leash, INCLUDING entering and exiting search areas in order to avoid dog to dog contact. Flexi leads are not permitted on trial grounds with the exception of inside the search area ONLY. Your dog may NOT leave the search area on a retractable leash of any kind.**

## RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

First Place . . . . .	Blue
Second Place . . . . .	Red
Third Place . . . . .	Yellow
Fourth Place . . . . .	White
Qualifying Score . . . . .	Dark Green

A New Title rosette will be awarded to all dog and handler teams finishing a title. First through Fourth in each category will receive a prize sponsored by the American Belgian Malinois Club.

**High Scoring Belgian Malinois:** ABMC will offer a prize to the first place Belgian Malinois in each class in Trial 1 Thursday and Friday.

Note, for purposes of Most Versatile Malinois competition, Trial 1 results only are taken into consideration each day.

**Super Sniffer:** Teams must qualify in all odor division elements offered, regardless of level split, in a single trial. Sponsored by Hey Jude Creative. This award is not limited by breed.

Ribbons and prizes will not be mailed.

## HIGH IN TRIAL & HIGH COMBINED DIVISION

HIT: Teams must enter and qualify in both standard tilting elements offered (Buried/Interior on Thursday, Container/Exterior on Friday) within the same level. HIT is awarded to the team with the fewest faults and fastest cumulative time. HIT is awarded in each level. Novice A and B are scored together and only one HIT will be awarded for Novice.

Teams winning HIT will earn a Rosette from ABMC and prize provided by Hey Jude Creative.

High Combined Division is not offered at this trial.

## NOTICE TO EXHIBITORS

### SAFETY, BEHAVIOR AND LIABILITY

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Belgian Malinois Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Belgian Malinois Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Belgian Malinois Club or any official thereof.

**Collars, Leashes and Harnesses:** **While not actively searching, dogs MUST be on a fixed length 6' or shorter leash, INCLUDING entering and exiting search areas in order to avoid**

**dog to dog contact.** During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

**All dogs must be on leash at all times**, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

## REFUNDS

**No entry fee will be refunded** if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

**Bitches in season** will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial. Refund only applies to the female in season, not to other dogs, not in season owned by the same exhibitor.

**Refunds will be mailed by the club** after the trial concludes.

**Entries not admitted to the trial and withdrawn entries will be shredded, not be returned to the exhibitor.**

**Requests for returned checks and money orders must be made in writing to the Trial Secretary by email before the closing date and a self addressed and stamped envelope must be provided by the exhibitor.**

## RINGSIDE

**Judges are not required to wait for dogs.** The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**EXHIBITOR CHECK-IN:** Like agility, we will not have physical arm bands for pickup, you will check in at the main steward board. Check In will begin at Barn Q at 7:00. Armband numbers will remain the same for all four trials. You must check in before the close of your class.

**Please observe social distancing while spectating.**

*Exhibitors MUST check-in EACH day they are entered.  
Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.*

*"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.*

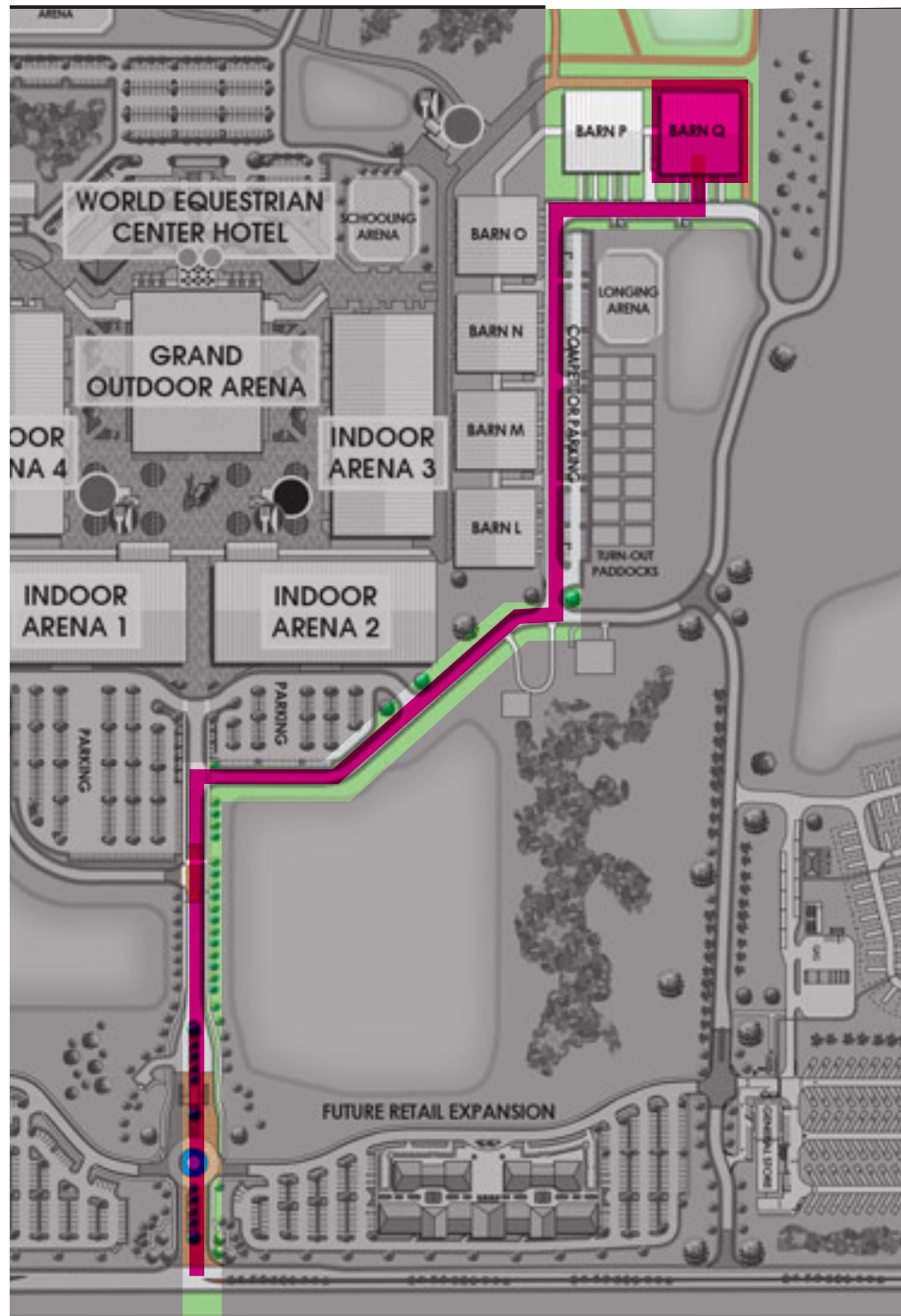

## Come one, come all!

We have volunteer opportunities available for the following positions for May 4, 5 and 6. We will need several people for each job so no one is required to work all day and so each person entered has the chance to run their dog. It usually works best for Excellent and Master people to help during the Novice and Advanced classes and the Novice and Advanced people can help during the Excellent and Master classes.

Volunteering is an exceptional way to learn how trials are run and in the case of Table Steward and Timer, a way to be able to watch many teams in action and learn from their successes and mistakes. I personally feel I have learned far more from volunteering than if I had just run my own dogs. For those in lower levels, it gives you a preview of what is to come. For those in higher levels, you still pick up valuable lessons at every level by watching other teams run. And we will have fun raffle prizes for our workers!

An important note: If you do not have previous experience at these jobs, we will teach you! Just send me a note stating you would like additional instruction and we will be sure to support you.

We cannot have trials without people that volunteer to make sure everything runs smoothly and everyone has a good time. If there is one thing I absolutely love about the Scent Work Community, it is we have a great group of people who pull together and make trials run efficiently and we cheer each other on!

### May 4th

**Set-up:** Help with set-up on the 4th. This will entail setting up a table and chairs for each Table Steward along with the table steward box containing all their equipment. Putting up tarps as needed to shield certain areas from view. Putting up stall signs for crating. Setting up Buried containers with sand & water. (No one person will be expected to do all of this but these are examples of what will be needed.)

### May 5 & 6

**Main Gate Steward:** This person is the primary check-point for all exhibitors to check in. You will check them in and direct them to the Element Gate Steward to queue up for their turn when it is time. You will have the run order lists for both Elements running that day. Radio contact with the Element Gate Stewards will be used so you know when they need more people. This person should be comfortable being outspoken (Bossy even) as you will have all the exhibitors looking to you for information and run times.

**Element Gate Steward:** This person will be responsible for managing the next three exhibitors in the run order. The Main Gate Steward will send you people as needed to keep your three chairs full. You should also keep track of who has already run (cross them off the list). (If someone comes directly to you to check in please send them back to the Main Gate person)

**Table Steward (one person needed for each level and element):** This person has a front row seat to the action. Your job is to keep the judges paperwork in order and make sure the next dog to the start line matches up with the paperwork the judge is given. It is good practice to review the paperwork afterwards to be sure the judge has circled "Qualified" or "Not Qualified", and if they qualified there should be a Time entered. Putting the sheets back in the correct Trial envelope in run order with any move-ups on top is appreciated by the Trial Secretary.

**Timer (one person needed for each level and element):** This person also has a front row seat

to the action. Your job is to use a stopwatch (sometimes a phone) to time the exhibitor. In all classes Time starts when the dog or handler crosses the start line. In Novice, Time stops when the exhibitor calls Alert! In Advanced, Time stops when the exhibitor calls Finish! In Excellent & Master Container, Buried and Exterior the "Finish" call will also stop the clock. Interior is a bit different. Interior Excellent and Master includes multiple areas to search. Each area will have it's own time limit. The "Finish" call will stop the clock for each area and the Times will be combined when completed. Don't worry, you'll be given instructions when you report for duty.

**Clean Up:** Picking up after the trial and loading up the trailer. Checking the grounds to be sure people have picked up after their dogs in the potty area and elsewhere. Removing stall signs (names on stalls for crating space).

Please feel free to contact me with any questions. And please let me know if you are interested in making this Trial one the American Belgian Malinois Club can be proud of!

If you'd like to volunteer, please let me know which jobs you're interested in and also what levels you plan to be running your own dog(s) so I can manage conflicts.

## AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. ## INSTRUCTIONS

Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers.
