***Judging Program***

*Welcome to the 2022 American Belgian Malinois Club National Specialty Tracking Test ! The test will be held on Tuesday, May 3, 2022, on the grounds of the Roberts Development Corporate Center, 7340 N US Highway 27, Ocala, FL 34482.*

**Entries:** There were 5 entries for this Test (3 Exhibitors and 2 Alternates). A drawing was held on Friday, April 22, 2022 at the Test Secretary's address to establish catalog order.

**Draw for Running Order and Test Start times:** Track order will be drawn on the day of the Test at 7:30AM in the parking lot at the tracking site (see directions next page). Exhibitors and spectators are asked to arrive no earlier than 7:00AM. All Exhibitors must be present at the draw to guarantee their participation in the Test. The first track will be run as soon as practical after completion of the draw. All times are approximate and weather permitting. The draw will be held in the parking lot at the tracking site.

**Awards:** At the end of the Test, Exhibitors with passing tracks will receive a rosette, an award and their final article, signed by the Judges and Tracklayer.

**Facilities & Hospitality.** Test hours are 7:00AM until the last track is completed. Please note, there are **NO** restrooms on site. Coffee and breakfast snacks will available the morning of the Test. Exhibitors must crate out of their vehicles. We ask that you use the designated exercise area, which the Judges will identify prior to commencement of the Test, and always clean up after your dog. All dogs must be on lead at all times; any dog that is allowed to run off lead at any time before or during a Test shall be excused and not allowed to run their track; or, if after a test, shall be failed (regardless if the dog had already passed) and excused. Practicing at the Test site is prohibited.

**Directions:**

*From World Equestrian Center:* Exit Main Gate and turn left (north) on NW 80th Avenue/Route 225A for approximately 2.4 miles, then turn left at the traffic light onto Highway 27 North (some GPS systems may identify this portion of Highway 27 as NW Blitchton Road). Continue for approximately .3 mile and turn left into the entrance drive to the Roberts Development Corporate Center at the large monument sign; proceed to parking lot ahead on the right.

*From I-75:* Take Exit 354 and turn onto Highway 27 North heading west (some GPS systems may identify a portion of Highway 27 as NW Blitchton Road); continue for approximately 3.8 miles. Approximately .3 mile past the traffic signal at NW 70<sup>th</sup> Avenue/Route 225A, turn left into the entrance drive to the Roberts Development Corporate Center at the large monument sign and proceed to the parking lot ahead on the right.
