TRACKING DOG TEST JUDGING PROGRAM

There were 5 entries for this Test (3 Exhibitors and 2 Alternates). A drawing was held on Friday, April 22, 2022 at the Secretary's address to establish catalog order.

Draw for Running Order and Test Start time: Track order will be drawn on the day of the Test at 7:30AM in the parking lot at the tracking site. Exhibitors and spectators are asked to arrive no earlier than 7:00AM. All Exhibitors must be present at the draw to guarantee their participation in the Test. The first track will be run as soon as practical after completion of the draw. All times are approximate and weather permitting.

Bitches in season: Bitches in season may participate provided that the Test Secretary and Judges are notified as soon as possible but no later than at the drawing for running order. The last track(s) laid shall be for the bitches in season. If there is more than one bitch in season, a second draw will be held. Bitches in season will be allowed to participate in a test only after all the other dogs and bitches not in season have been tested. Bitches in season must be kept in their owner's vehicles at all times unless running their designated track or pottying in a separate area.

Refunds: Entry fees will be refunded/returned to Alternates who decline to be placed on the Alternate list, and entry fees will be refunded/returned to Alternates who do not participate in the Test. Entry fees will <u>not</u> be refunded/returned to a scheduled Exhibitor who is absent on the Test day <u>unless</u> an Alternate is present and runs in the place of the absent dog. Entry fees (and certifications) for Alternates who do not participate in a Test will be refunded/returned as soon as possible but no later than one (1) week of the completion of the Test.

Facilities & Hospitality. Test hours are 7:00AM until the last track is completed. Please note there are no restrooms on site. Complimentary coffee and breakfast snacks will be served the morning of the Test. Exhibitors must crate out of their vehicles. We ask that you use the designated exercise area, which the Judges will identify prior to commencement of the Test, and always clean up after your dog. All dogs must be on lead at all times; any dog that is allowed to run off lead at any time before or during a Test shall be excused and not allowed to run their track; or, if after a test, shall be failed (regardless if the dog had already passed) and excused. Practicing at the Test site is prohibited.
