Other Trial Information

Sheep Runs are limited to 50 runs, and Trial classes will take precedence over Test entries (unfilled trial sheep runs will go to Test runs in the order received).

Handler meetings start at 8 am each day. FARM GATES OPEN at 7 am.

Replacement Values:

Injured livestock expenses, including veterinary and disposal fees will be the responsibility of the handler/owner. Replacement cost of livestock are Sheep \$350; Ducks \$50. A medication fee of \$20, the veterinarian's bill, or the cost of the animal will be charged to the owner of any dog causing damage to livestock, whether such damage is caused directly or indirectly by the dog.

Other Information

Email will be used as a primary means of communication if an email address is listed on the entry form unless entrant requests otherwise.

Entries not on official AKC entry forms or photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC entry form are not acceptable.

Incomplete or unsigned entries cannot be accepted.

Returned checks do not constitute a valid entry. The secretary will add \$50 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in the exhibitor's entries being accepted on a Cash Only basis.

Errors on Entry Blanks: Owners are responsible for errors in filling out entry forms, whoever may make such errors. No entry fee will be refunded in case of any such errors after the closing date.

Declination of entries: ABMC may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or other cause, and no one shall have recourse against ABMC, an official thereof, or any judge.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Test/Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the organizing committee, it is impossible to open or complete the test/trial, no refund of entry will be made. Extreme weather conditions, including, but not limited to snow storms, hurricanes, lightning or extreme temperatures must be considered for the health and safety of the dogs, livestock, exhibitors, judges and spectators. The well being of dogs, livestock exhibitors and spectators is of paramount importance. In the event it is necessary to cancel or stop the test/trial before completion, no refund of entry fee will be made. No entry will be refunded after closing date.

No refunds will be given for overpayment of fees if the error is less than \$10.00

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable disease, and have appropriate vaccinations.

No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any trial.

When not competing, dogs must be confined or held on leash and kept away from the livestock

The American Belgian Malinois Club, Inc, and the owner of Rosehaeven Farm, the Judges and the Trial Secretary assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or spectators, or by any of their dogs or property.

Children must be kept under the control of their parents or guardians at all times and must be kept away from all farm equipment and livestock.

No unauthorized persons or dogs allowed in barns or house.

Wading pools will be available for your dogs.

Please note: No smoking or Vaping on the grounds at any time.

REFUNDS/ALTERNATES

Entries received after the numerical limits have been reached but prior to closing will be placed on an alternate list.

If you pull your entry(ies) prior to closing your check will be shredded.

If your dog is pulled after entries close and an alternate fills your place, a full refund will be made.

If your dog is pulled after entries close without an alternate taking your place, no refund will be made. In the event of a spouse, sibling, parent or entered dog's passing, a board decision will be made.

If you are an alternate and pull prior to closing your check will be shredded.

If you are an alternate and do not have an opportunity to run, you will receive a full refund.

If you are an alternate, have the opportunity to run and are not present to run your dog, no refund will be made.

Entrants on the alternates' list must check in with the Trial Secretary on the Trial grounds no later than thirty (30) minutes prior to start of trial each day.

DIRECTIONS TO ROSEHAEVEN FARM

From North or South: Travel I-75 to Lima, exit 125, toward Kenton/Lima. Turn east on Harding Hwy/OH-309, then 10 miles to South Hardin Rd/County Hwy-15, right/south, then in one mile, turn left on County Rd 80. In 1 ¼ miles, you will reach Rosehaeven on the right. House cannot be seen from the road, has a long driveway.

From East or West: Travel to I-75, then follow directions above.

Due to the construction of the driveway, RVs will not be able to use the driveway, we will try to make alternate arrangements. There is a campground close by (listed above). There is no overnight parking allowed on site.

DANGER Hot Fence

The fence along the driveway is a HOT fence, belonging to the neighbor; please be careful not to touch the fence.

Course Direction

The course direction will be determined by the judge the day before the trial.

Entry forms must be signed, and include email and phone number.
