Trial Sheep Runs – 5 sheep, Dorper and Dorper Crosses

Test Runs – 3 sheep, Dorpers and/or Dorper Crosses

Ducks A & B – 5 ducks per run, Calls and Call Crosses

Replacement Values:

Injured livestock expenses, including veterinary and disposal fees will be the responsibility of the handler/owner. Replacement cost of livestock are Sheep \$350; Ducks \$50. A medication fee of \$20, the veterinarian's bill, or the cost of the animal will be charged to the owner of any dog causing damage to livestock, whether such damage is caused directly or indirectly by the dog.

Handler meetings start at 8 am each day. FARM GATES OPEN at 7 am.

DIRECTIONS TO ROSEHAEVEN FARM

From North or South: Travel I-75 to Lima, exit 125, toward Kenton/Lima. Turn east on Harding Hwy/OH-309, then 10 miles to South Hardin Rd/County Hwy-15, right/south, then in one mile, turn left on County Rd 80. In 1 ¼ miles, you will reach Rosehaeven on the right. House cannot be seen from the road, has a long driveway.

From East or West: Travel to I-75, then follow directions above
