**Test Hours:** are 6:00 am to 7:00 pm May 14, 2026. Michigan is in the Eastern Daylight Time Zone. On Thursday, May 14, 2026, all dogs in the **TD test** are to be available at Test HQ **at 7:15 am**. The draw for running order will take place **at 7:30 am**. TD judging will begin as soon after the draw as the first track is ready.

All dogs in the **TDX test** are also to be available at Test HQ **at 7:15 am**. The draw for running order will take place **immediately following the draw for the TD test** (scheduled at 7:30 am). TDX judging will begin as soon as possible after the TD test is complete and when the first TDX track is ready.

**MANAGEMENT OF DOGS AT TEST:** Dogs must be leashed or crated at all times. Please pick up after your dog.

---

**BITCHES IN SEASON:** Bitches in season may participate in the test provided that the Test Secretary and Judges are notified of same prior to the drawing of tracks. The last track(s) laid shall be for the bitch(es) in season. If there is more than one bitch in season, a second draw for those bitches will be held. Bitches in season will be allowed to participate in a test only after all other dogs and bitches not in season have been tested.

**YOUR DOG'S HEALTH:** Exhibitors should follow their veterinarian's recommendations to assure that their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Expect the possibility of ticks in the tracking fields. Protect yourself and your dog accordingly.

### **TRACKING DOG EXCELLENT TEST – (2) TRACKS**

(2) Entries: TDX1, TDX2

(2) Alternates: TDX ALT 1, TDX ALT 2

**REFUNDS** of entry fees for alternates who don't participate in the test will be sent within one week of the completion of the test. Entry fees for dogs which pass an AKC approved test after the closing date of this test will be refunded if they withdraw from this test provided there is an alternate to replace the entry and the Test Secretary is notified in writing not less than 3 days before the test date. Any cancellation of entries must be made in writing and received prior to the closing date.

**TROPHIES:** Each passing dog will be awarded a Club Rosette and a trophy item with the ABMC logo. CT Rosette available. The American Belgian Malinois Club (ABMC) offers trophies through the generosity of donors to the trophy fund. All donor names will be listed in the specialty catalog. All ribbons, awards and trophies, if not awarded in the ring, must be picked up by the exhibitor. No trophies will be mailed. Rosettes are offered for all awards and placements by ABMC. Trophies of greater or equal value may be substituted at the discretion of the Test or Trophy Chair.

The draw for track order for both tests will take place at the ANN ARBOR DOG TRAINING CLUB, 1575 E. North Territorial Road, Whitmore Lake, MI 48189

#### **From the North:**

- US-23 south to exit 49 - N. Territorial
- Turn left onto N. Territorial
- Go about 1+ mile over the railroad tracks
- Turn left onto Hoban Way
- Building at end of road

#### **From the South / East / West:**

- M-14 or I-94 to US-23 north to exit 49 - N. Territorial
- Turn right onto N. Territorial
- Go about 1+ mile over the railroad tracks
- Turn left onto Hoban Way
- Building at end of road
